Minutes of the 6th Dispensary Management Committee (DMC) meeting held on 30-09-2025 at 1130 hrs.

The 6th meeting of the Dispensary Management Committee (DMC) was convened at the Surveyor General's Office under the chairmanship of Surveyor General of India. The list of committee members who attended the meeting is enclosed in Annexure I. Incharge, CMO, SoI Health Centre attended the meeting in online mode through VC.

The chairman welcomed the committee members. The following issues were discussed to ensure proper management and better functioning of SoI Health Centre.

AGENDA No. 01: Action taken on the decision made in last meeting held on 24-06-2025.

- (i) I-cards: Incharge, CMO has informed that total 1695 cards have been distributed till date.
- (ii) Expansion of Health Centre in terms of equipment including dental equipment: Incharge, CMO has informed that no further expansion in terms of equipments has been done from last DMC meeting
- (iii) Facility of Health Centre to transferred/ retired/superannuated employees: Incharge, CMO has informed that the facility for the employees and his family members is being provided for maximum of 01 month after his transfer. Retired and superannuated staff members cards are being blocked on the date of retirement /superannuated.
- (iv) Procurement of medicines: The medicines are being procured from GSMD. The medicines which are not available in GMSD, those are being procured from CGHS authorized ALC/ Jan Aushidhi Kendra only.
 - Incharge, CMO further informed that dental consumables are also being procured from CGHS authorised ALC.
- (v) OPD Data: Incharge, CMO has informed that proper analysis of the data is being done.

AGENDA No. 02: Funds Utilisation

The total fund utilised till 26-09-2025 was ₹ 17,10,494/- against total allotment of ₹ 45 Lakhs.

Then

SGI emphasized that maximum funds are to be utilised.

AGENDA No. 03: Others

(i) CGHS Cards: The committee is of the opinion that the CGHS cards of all the employees should be prepared.

SGI inquired about the status of CGHS cards issued to Survey of India employees and their family members by CGHS. Additional Director, CGHS, informed that the majority of cards have already been issued to the applicants, and the remaining cards will be issued at the earliest.

SGI has directed that all CGHS cards be prepared in the earliest possible time, and the corresponding CGHS card numbers be integrated into the existing Health Centre software. Additionally, the SoI Health Centre beneficiary cards of employees who have been issued CGHS cards should be retrieved.

The committee is also of the view that Health Centre facilities should not be extended to employees and their family members who have not applied for CGHS cards.

(ii) The Additional Director, CGHS, inquired about the issuance of restrictive medicines.
The Incharge CMO informed the committee that all restrictive medicines are being procured in accordance with CGHS procedures.
