ORDER

With the approval of Competent Authority, it has been decided that Shri Manoj Kumar, Director, IFD, Department of Science & Technology in addition of his duties will look after the work of Director (Finance) as Financial Advisor only to the Surveyor General of India as a temporary measure with immediate effect till appointment of regular Director (Admin & Finance), Sol or until further orders, whichever is earlier.
