Sub: Implementation of the decision of the Union Cabinet for permanent reversion of defence stream officers seconded to Survey of India to Military Survey, Ministry of Defence – regarding.

With reference to the subject mentioned above, it is to say that the Union Cabinet has approved on 16.12.2022 the National Geospatial Policy 2022 to strengthen the geospatial sector of the nation. Para 5.2.2.7 of the policy, inter-alia, says that the **defence stream officers seconded** to Sol would be permanently reverted to Military Survey, Ministry of Defence.

- 2. The para 5.2.2.7 of NGP is required to be implemented as per the provisions of the Survey of India Group 'A' Service Rules, 1989 and by fleshing out the policy into implementable instruments after due consultation and considering the aspirations and grievances of all the stakeholders including the applicants.
- **3.** This office has been instructed to seek by 10th March, 2023, the aspirations and grievances of the defence stream officers as well as the civil stream officers of the Survey of India Group 'A' service in respect of implementation of para 5.2.2.7 of the policy mentioning, inter-alia, that the defence stream officers seconded to SoI would be permanently reverted to Military Survey, Ministry of Defence.
- **4.** Accordingly, the officers of both the streams of Survey of India Group 'A' service may submit their aspirations and grievances, if any, in respect of implementation of para 5.2.2.7 of the policy mentioning, inter-alia, that the defence stream officers seconded to Sol would be permanently reverted to Military Survey, Ministry of Defence. Any comment received after 10<sup>th</sup> March 2023 will not be considered.
