- 3. All sanctions issued under this delegation must comply with the relevant financial rules, guidelines and procedures.
- 4. A monthly consolidated report of all financial sanctions issued under this delegation shall be submitted to the office of the Surveyor General for review and record.
- 5. This delegation of financial powers shall come into effect immediately and shall remain valid until further orders.
