It may be made clear to the officers concerned that in case of their refusal of promotion, no fresh offer of promotion will be made to them for a period of one year from 23-10-2018 in terms of para 17.12 of of DoP&T's O.M.No.22011/5/86.Estt. (D) dated 10-04-1989 and they will lose seniority vis-a-vis his juniors promoted to the higher grade.
- 4. In case of any vigilance case/disciplinary proceedings or pendency of punishment against the above officials is noticed at your end, the promotion orders may not be implemented.
