(D) dated 10-04-1989 and they will lose seniority vis-a-vis their junior will be promoted to higher grade. The promotion of the officers will be subject to outcome of CWP No.20237/2009 in the Hon'ble High Court of Punjab & Haryana, Chandigarh.
