3. Necessary certificate of assumption of charge in respect of the above officers may please be sent on Form O.115 (Acc.) to this office, in duplicate, for issue of Gazette Notification.

4. After reporting in the new Office of posting, the above officers are required to undergo training in "Fundamentals of Survey Engineering" Course which will be intimated separately by this office. If they do not successfully complete the training or not found fit, they may be relegated by six months, but if still found not upto the required standard, they will be reverted back to their original post.

5. The above officers will be on probation for a period of two years from the date of their regular promotion as Officer Surveyor (Group 'B'). Necessary Assessment Reports on the work and performance of the officers have to be made available to this office for the said period.

6. Necessary action for re-verification of caste/tribe/PH status of persons belonging to Scheduled Caste/Scheduled Tribe/Physically Handicapped may please be taken, on their reporting for duty, on promotion by the concerned Director and they should be promoted with a clear stipulation that in case their re-verification, if it is found that they do not belong to Scheduled Caste/Scheduled Tribe/ Physically Handicapped category, they will be reverted to their previous grade forthwith.

7.. On promotion, the individuals would be required to exercise an option under FR 22(l)(a)(1) for fixation of their pay in the new level within one month of reporting.

8. In case of any vigilance case/disciplinary proceedings or pendency of punishment against any of the above officials is noticed at your end, the orders of promotion may not be implemented and this office be informed accordingly.
