- Preparation of SoPs/Work flow document for: 2.
  - a. Issuing Supply Order to Empanelled Firms,
  - b. Measurement of deliverables,
  - c. QA/QC of Deliverables,
  - d. Payment for Services,
  - e. Imposition of Penalties for lack of performance and
  - f. Preparation of Returns/ reporting formats for Assessment of performance of Empanelled Firms and quality of work/services.
- Distribution of work and Contract Management.
- Quarterly and/or Intermediate Assessment of Work load of Sol under different Projects and equitable distribution of work load amongst Empanelled Firms in accordance with available quantum of work, Geographical proximity, Capacity of each empanelled Firm, performance of agency & quality of the service provided by agencies, customer satisfaction and other relevant Provisions of Tender Document.
- Quarterly and/or Intermediate Assessment of Performance of Empanelled Firms and 5. recommendation of Cancellation of the empanelment contract if required.
- Assessment of Drone teams, if required, while augmenting number of Drone teams under 6. empanelment in accordance of provisions of Tender document.
- 7. Examine cases of:
  - a. Modification of the terms and conditions of Contract, including any modification of the scope of the Services,
  - b. Payment for Additional Services,
  - c. Modification of Service Level Agreement,
  - d. Force Majeure conditions,
  - e. Breach of Contract.
  - f. Compensation to Service Provider's (except in scenarios defined in SCC 9.1.9),
  - g. Employer's Prior Approval for Removal and/or Replacement of contractor's Personnel
