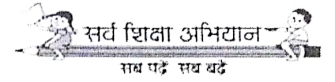

2. The board shall conduct the subject examination for filling of vacancies accrued for the years 2023 and 2024 of Officer Surveyor Posts. The cumulative vacancies of these two years will be filled through single selection examination as per procedure prescribed in existing LDCE Scheme, 1991 (Selection to Officer Surveyor's Grade), which has concurrence of the DST.

3. The year-wise vacancies to be filled through subject examination are shown in following table:

Year	Unreserved	SC	ST	Total
2023	16	7	5	28
2024	4	1	0	05
Total	20	8	5	33

The above vacancies are tentative which also include the vacancies reserved for PwBD. The exact number of vacancies and the vacancies reserved for PwBD will be intimated in due course.

4. The above vacancies are subject to the outcome of orders of Hon'ble Court in the following cases:-
- OA. No. 1506/2018 filed by Shri P.M. Krishna V/s Union of India and others before the Hon'ble CAT, Madras Bench, Chennai. However, the Hon 'ble High Court of Judicature at Madras has ordered to maintain status quo vide order dated 10-12-20 8 in W.P. No. 31893/ 2018 filed by Shri P.M. Krishna.
 - O.A.No. 388 of 2018 - filed by Shri Akash Ranjan Singh in the Hon'ble CAT, Patna Bench, Patna.
 - O.A.No. 519 of 2018 - Filed by Shri Jasbir Singh Bangari V/s Union of India & others before the Hon'ble Tribunal, Chandigarh Bench.

5. Those Surveyors and Survey Assistants who have completed 05 years regular service in the grade of Surveyor and Survey Assistant as on the crucial date for eligibility (as mentioned below) and have the minimum educational qualification etc. as stipulated in LDCE Scheme shall be eligible to appear at the examination. The crucial dates for eligibility will be as under:-

- 1st Jan, 2023 for 2023 Examination
- 1st Jan, 2024 for 2024 Examination

6. A candidate eligible for appearing in any year's examination is also eligible for subsequent year's examination subject to fulfillment of all other eligibility conditions.

7. After the examination, a consolidated merit list for all the vacancies for 2 years i.e. 2023 and 2024 will be prepared. However, the results shall be declared separately for each year to ensure that if vacancies remain unfilled in the year 2023, the same are carried forward to next vacancy year. Year wise merit lists will be based on the number of vacancies, candidate's position in consolidated merit list and fulfillment of all other eligibility conditions. Based on his/her merit, and subject to vacancy position and other eligibility conditions, a candidate will be placed in the appropriate year wise select list. If a candidate's name is included in the select list for a particular category for a particular year, his/her name will not be considered for inclusion in other list(s). Vacancies remaining unfilled in any of the years due to non-availability of suitable/qualified candidates, will be carried forward to the next Vacancy year.


7. Select list of candidates for each year including candidates belonging to the Scheduled Castes and the Scheduled Tribes will be decided based on the guidelines to be issued by the Department of Personnel & Training as per the outcome of the pending litigation in SLP (C) No. 30621/2011 and SLP (C) No. 31288/2017.

8. Candidate should clearly make aware that this is a competitive and not a qualifying examination. The number of persons to be included in each Select list based on the result of the examination is entirely within the competence of Government to decide. No candidate will therefore have any claim for inclusion in the Select List on the basis of his/her performance in this Examination as a matter of right.

9. To conduct the said exam further guidelines are issued as under:-

- i. Three sets of question papers are to be prepared of which one set is to be randomly selected by the Board.
- ii. Evaluation of answer sheets is to be done by the Board and the final result to be submitted to SGO.
- iii. The complete process of selection must be completed at the earliest.

This issues with the approval of the Surveyor General of India.
