
The Subject Main Examination has been held on 25-08-2022 and 26-08-2022 in the Office of NIGST, Hyderabad. The Answer Keys for both Paper-III (Pure Mathematics) & Paper- IV (Applied Mathematics & Physics /Surveying) of Main Examination are enclosed herewith. All the candidates who appeared for the subject examination are advised to go through the Answer Keys. The objections, if any, on the Answer Keys have to be submitted by the candidates (only) with full details from their respective personal Government Email IDs to the Office Email ID of NIGST (i.e.) [iism.soi@gov.in](mailto:iism.soi@gov.in) by 29-08-2022 (upto 10:00 hrs).

2. The objections (on the Answer Keys displayed) which are found to be vague and not clear will be ignored. If no objections are received on the displayed answer keys before the above mentioned date and time, the keys displayed will be treated as final for further action. In case of receipt of any valid objections, the same will be considered by the board for taking appropriate action on the matter, if required.

3. **Note: For the candidates who opted for Applied Mathematics & Physics as option under Paper IV**

As 02 (Two) questions bearing Nos. 39, 40 have been found to be repetitions of Question Nos. 37 and 36, these two questions i.e., bearing Nos. 39 and 40 have to be treated as **DROPPED**. Therefore, for the purpose of evaluation of this Paper, only 98 Questions (with maximum marks of 147) will be considered and accordingly marks actually secured out of 147 will be used for recalculation of the corresponding number of marks secured out of 150 marks in respect of Paper IV (Applied Mathematics & Physics) of Main Examination.
